# Technical Working group

The role of the Technical Subgroup is to identify and support the implementation of common existing digital solutions on a large scale in the EU to support the three principles given in the Living-in.eu declaration regarding the technical commitment:

- Use common standards and technical specifications,
- Make key enablers (including data, infrastructure and services) available to all,
- Establish a common market.

For 2024, the Technical subgroup focuses on supporting the continuing development of MIMs Plus within the context of European legislative measures and policy proposals. Based on the experience of working on the MIMs over the last few years, the Living-in.EU technical working group is in the process of reviewing the MIMs Plus to provide them with a consistent structure (Y.MIM) and greater clarity. It will do this in the context of the developing work on Data Spaces for Smart & Sustainable Cities and Communities, Local Digital Twin Toolbox, CommuniCity, CitCom.AI and other relevant European projects pertaining to the digital transformation of European communities.
