Local Data Platforms

Local data platforms are central hubs that collect, store, and manage diverse data from various sources in a city or community.



Data Spaces

Data spaces are infrastructures facilitating data transactions among different parties in each ecosystem.

Local digital twins are virtual models of a city's physical assets, using data, analytics, and AI to simulate real-world scenarios.

Minimal Interoperability Mechanisms (MIMs)

Common set of standards and technical specifications to achieve interoperability of data, systems, and platforms among cities and communities and suppliers around the world.



"Local and Regional Digital Maturity **Assessment**". It is an interactive tool aimed at helping local and regional authorities to understand where they are in their digital transition journey.





AI Procurement Clauses

Vital contractual terms ensuring **responsible Al** system acquisition by public authorities, fostering transparency, accountability, and trust.




Living Lab approach

Living-in.EU Working Groups

The Third Open Call

- Organised by OASC
- For whom? All EU cities and associations can participate
- 62 pilots will be granted with a minimum of € 12 500 grants

Timeline

- Open Call launching: 10 September 2024
- Evaluation: November 2024
- Announcement of winning pilots: December 2024
- Pilots run from December 2024 to May 2025





Why should cities and associations join?

- Gain knowledge and experience in co-creation with marginalized groups and boost their engagement in your city.
- Promote tech development for the benefit of marginalized groups and utilize CommuniCity technical components and tools.
- Receive guidelines for a successful Open Call and piloting process, and replicate solutions developed in other European cities.

Open Calls – A catalyst for innovation and collaboration

"Publicly disseminated invitation for submissions in the form of a tender or application. Invitation typically outlines the specific requirements and criteria for participation, and it seeks contributions from a broad and diverse audience."

Open calls offer a powerful tool for organisations seeking to:

- **Diversify their talent pool and perspectives** Leads to more comprehensive solutions, higher levels of innovation and a richer pool of potential collaborators.
- **Spark creative solutions** The open nature of the call encourages participants to think outside the box resulting in unexpected and groundbreaking innovations.
- Build trust and credibility Resulting in wider range of individuals and organisations participating, ultimately leading to a more robust pool of applications.

CommuniCity Open Call Manual

- CommuniCity Open Call Manual provides general guidelines for organizing and conducting open calls for pilot programs. It also includes practical, real-life examples from the CommuniCity project.
- Currently, the CommuniCity project is using Open Call Manual to manage the final round of open calls launched on 10 September 2024.
- The content will be updated during the final round of the CommuniCity open calls, with the final version published by August 31, 2025.

Preparations

To create a successful open call, start by establishing **clear objectives**. Then, formulate the specific challenge(s) you want addressed.

Next, carefully consider the **expected outcomes** and **impact** of the open call. This will help you tailor the evaluation criteria to effectively assess the submitted applications.

Finally, establish a **comprehensive framework** that encompasses legal considerations and available resources. This framework defines the parameters of the open call, including overall scope and scale.

Running the open call

By building **trust** with potential applicants after launching the open call, the open call host organization can attract stronger applicants, pave the way for successful pilot projects, and foster collaboration.

It is also crucial to actively **promote** the open call and **engage** with potential applicants through targeted outreach, social media campaigns, and tailored events such as informative sessions.

Evaluation of the applications

To ensure a **professional and fair evaluation** of the applications, invest enough time and resources to select evaluation jury members. Pay attention to their professional expertise and experience.

Furthermore, carefully selected **evaluation criteria** and **scoring systems** ensure the selection of the highest-quality applications with the strongest potential for success.

Finally, providing **constructive feedback** to all applicants demonstrates respect for their efforts and strengthens the applicant pool for future open calls.

Closing the Open Call

After the open call closes, jury members begin their assessment of the applications. Upon completion of their evaluation – including the delivery of verbal feedback and/or scores to applicants – the open call results can be **publicly announced**.

The final step involves signing a **Piloting Contract** between the open call host organization and the chosen piloting team.

CommuniCity Manuals

The first versions of the manuals are targeted to cities participating in the CommuniCity Open Calls in 2023-2025. By the end of August 2025 these manuals serve all cities organising their own open calls and running agile pilots.

<u>CommuniCity</u> is a transformative citizen-centred project funded by the European Commission.



Instruction Manual for arranging Open Calls for Piloting

The Open Call Instruction Manual provides general guidelines for organising and conducting open calls for glob programs. The CommuniCity project is currently utilising this manual to manage its open-call nounds running from 2023 to 2025.


The content of this microard is expected to evolve during the Communicity project. The final evolution, to be published by August 394, 2025, will be edited to include a comprehensive left of instructions along with handler on examples from the Communicity project.



Toolkit for organising Agile Piloting Programmes

The Ploting Toolkit is designed to assist with cocreating innovative solutions to match the challenges of the communities.

It is based on agile piloting methodiology and will help pilot monogers from cities and M30s manage their technology pilots in a way that benefits all stakeholders.





Pilot example from CommuniCity

Challenge: How the disabled can improve their skills by using virtual technologies?

Solution: InclusiVerse is a VR-based application from <u>CTRL</u> <u>Reality</u> for Meta Quest headsets.

The solution aims to enhance the social and digital skills of adults with developmental disabilities.

Safe and motivating virtual environment to practise new skills: grocery shopping, riding a bus and job interviews.

150 clients of the 'Virtual Services Unit of Disability' participated in the co-creation sessions and tested the VR application in 2023.







CommuniCity Piloting Toolkit

- Developed during the three open call rounds of CommuniCity project
- First version has been used by the piloting cities of the 2nd open call round
- Final version ready in summer 2025
- Targeted for all communities to independently arrange open calls and run piloting programmes
- Includes practical guidance, cases and tools to ease the tasks of the pilot managers




