During the second part of the event, the interactive session, the participants had the opportunity to identify hindering and enabling factors for open calls and pilots, as well as discuss and vote on the most common/troublesome. Below is the list of additional contributions.

Enabling factors

- 1. Collaboration with experts, associations,
- 2. Support for scaling up business case and finance models
- 3. Availability of data that are open and accessible
- 4. Clear targeted communication about the process
- 5. Jointy aligned pilot plan
- 6. Process facilitators
- 7. Sufficient resources
- 8. Matchmakers

- 9. Availability of the pilot hosts organisations
- 10. Understanding of the real-life environment and problems

Hindering factors:

- 1. Add-hoc pilots with no scale-up potential
- 2. No open-source thinking at the start
- 3. Resources
- 4. Segregation and siloed infrastructure
- 5. Clear and engaging policy objectives at regional level
- 6. Low number of people turning up and continuously participating
- 7. Lack of awareness from the public on the concept of pilot and how to benefit by participating
- 8. Finding the right people and partners
- 9. Legal constraints
- 10. Enough funding after the pilot
